The paper is perhaps the most comprehensive discussion of NI we have seen and incorporates competency levels for the four domains of nursing. We offered our opinions on the competencies and the challenges facing the health system and the discipline of nursing as we continue to struggle with a way to clearly define, document and evaluate what we do. Some of the challenges we rated as high were lack of funding, lack of health information system infrastructure and lack of educational opportunities in Nursing Informatics. Nancy presented the case for a unified nursing language and explained the initiatives taking place at the national level. Good feedback from the group was received and the overwhelming theme which arose was the need for education in NI.
